Standards for Training Packages

Purpose of the Standards

The purpose of the Standards for Training Packages is to ensure Training Packages are of high quality and meet the workforce development needs of industry, enterprises and individuals.

The Standards for Training Packages apply to the design and development of Training Packages for endorsement consideration by the National Skills Standards Council (NSSC).

Training Packages - products

Standard 1: Training Packages consist of the following:

1. NSSC endorsed components:
 - units of competency;
 - assessment requirements (associated with each unit of competency);
 - qualifications; and
 - credit arrangements.
2. One or more quality assured companion volumes.

Training Packages - policy

Standard 2: Training Package developers comply with the NSSC Training Package Products Policy.

Standard 3: Training Package developers comply with the NSSC Training Package Development and Endorsement Process Policy.

Training Packages - components

Units of Competency

Standard 4: Units of competency specify the standards of performance required in the workplace..

Standard 5: The structure of units of competency complies with the unit of competency template.

Assessment Requirements

Standard 6: Assessment requirements specify the evidence and required conditions for assessment.

Standard 7: Every unit of competency has associated assessment requirements. The structure of assessment requirements complies with the assessment requirements template.

Qualifications

Standard 8: Qualifications comply with the Australian Qualifications Framework specification for that qualification type.

Standard 9: The structure of the information for the Australian Qualifications Framework qualification complies with the qualification template.

Credit Arrangements

Standard 10: Credit arrangements existing between Training Package qualifications and Higher Education qualifications are listed in a format that complies with the credit arrangements template.

Companion Volumes

Standard 11: A quality assured companion volume implementation guide produced by the Training Package developer is available at the time of endorsement and complies with the companion volume implementation guide template.

Standard 12: Training Package developers produce other quality assured companion volumes to meet the needs of their stakeholders as required.

Unit of Competency Template

UNIT CODE <i>MANDATORY FIELD</i>	The unit code contains the three alpha characters identifying the Training Package, followed by alpha and/or numeric characters. It must comply with the length specified in the AVETMIS Standard (no more than 12 characters).
UNIT TITLE <i>MANDATORY FIELD</i>	The title concisely describes the unit outcome. It must comply with the length specified in the AVETMIS Standard (no more than 100 characters)
APPLICATION <i>MANDATORY FIELD</i>	The application section briefly describes how the unit is practically applied in the industry and in what context(s) the unit may be applied. It Includes: <ul style="list-style-type: none"> ■ a summary statement of unit content; ■ focused, useful information on how and where the unit of competency could be practically applied and who might use it; and ■ the unit of competency's relationship to any licensing, legislative, regulatory or certification requirements. Where no requirements exist, insert: <i>No licensing, legislative or certification requirements apply to this unit at the time of publication.</i>
PREREQUISITE UNIT <i>OPTIONAL FIELD</i>	List any unit(s) in which the candidate must be deemed competent prior to the determination of competency in this unit.
COMPETENCY FIELD <i>OPTIONAL FIELD</i>	Used only when the Training Package developer wishes to categorise a set of units within a Training Package in relation to a type of work.
UNIT SECTOR <i>OPTIONAL FIELD</i>	Used only when the Training Package developer wishes to categorise a set of units within a Training Package in relation to an industry sector.
ELEMENTS <i>MANDATORY FIELD</i>	PERFORMANCE CRITERIA <i>MANDATORY FIELD</i>
Elements describe the essential outcomes.	Performance criteria describe the performance needed to demonstrate achievement of the element.
1. Elements describe actions or outcomes that are demonstrable and assessable.	1.1 Performance criteria clearly relate to the element. 1.2 They are expressed as a standard. 1.3 They specify the required performance in relevant tasks, roles, and skills. 1.4 They reflect the applied knowledge that enables competent performance.
FOUNDATION SKILLS <i>MANDATORY FIELD</i> <p>This section describes those language, literacy, numeracy and employment skills that are essential to performance.</p> <p>Foundation skills essential to performance in this unit, but not explicit in the performance criteria are listed here, along with a brief context statement.</p> <p>Where all foundation skills essential to performance in this unit are explicit in the performance criteria insert: <i>Foundation skills essential to performance are explicit in the performance criteria of this unit of competency.</i></p>	
RANGE OF CONDITIONS <i>OPTIONAL FIELD</i> <p>Specifies different work environments and conditions that may affect performance. Essential operating conditions that may be present (depending on the work situation, needs of the candidate, accessibility of the item, and local industry and regional contexts) are included.</p> <p>Range is restricted to essential operating conditions and any other variables essential to the work environment.</p>

PERFORMANCE EVIDENCE <i>MANDATORY FIELD</i>	<ul style="list-style-type: none"> ■ specifies the required product and process evidence. ■ specifies the frequency and/or volume of product/process evidence. ■ specifies the relationship between the product and process evidence and the performance criteria.
KNOWLEDGE EVIDENCE <i>MANDATORY FIELD</i>	<ul style="list-style-type: none"> ■ specifies what the individual must know in order to safely and effectively perform the work task described in the unit of competency. ■ relates directly to the performance criteria and/or range of conditions. ■ indicates the type and depth of knowledge required to meet the demands of the unit of competency.
ASSESSMENT CONDITIONS <i>MANDATORY FIELD</i>	<ul style="list-style-type: none"> ■ stipulates any mandatory conditions for assessment. ■ specifies the conditions under which evidence for assessment must be gathered, including any details of equipment and materials, contingencies, specifications, physical conditions, relationships with team members and supervisor, relationship with client/customer, and timeframe. ■ specifies assessor requirements, including any details related to qualifications, experience and industry currency.

It must comply with the length specified in the AVETMIS Standard.</p>
QUALIFICATION TITLE <small>MANDATORY FIELD</small>	<p>A unique title that reflects the qualification outcome. It must comply with the length specified in the AVETMIS Standard (no more than 100 characters).</p>
QUALIFICATION DESCRIPTION <small>MANDATORY FIELD</small>	<p>A description of the qualification outcomes.</p> <p>Any licensing, legislative, regulatory or certification considerations. Where none exist insert:</p> <p><i>No licensing, legislative or certification requirements apply to this qualification at the time of publication.</i></p>
ENTRY REQUIREMENTS <small>OPTIONAL FIELD</small>	<p>Specifies any mandatory entry requirements</p>
PACKAGING RULES <small>MANDATORY FIELD</small>	<p>Specifies the total number of units of competency required to achieve the qualification.</p> <p>Specifies the number of core and elective units.</p> <p>Lists all core and elective unit codes and titles, including prerequisite units where they apply.</p>
